Notice to Affected Residents


CHUN WO-SINOHYDRO JV is the main contractor for the Water Supplies Department's contract 21/WSD/21. This Project is to relocate the existing Diamond Hill Fresh Water and Salt Water Service Reservoirs and associated facilities to caverns so as to release the existing site for housing and other uses beneficial to the people's livelihood while continuing to ensure a reliable, adequate and quality supply of water.

We wish to inform you that heavy machinery lifting work will be conducted near the construction site on access road leading to Lion Road Park, from October 28 to November 3, 2024 (one night only) between 7:00 PM and 7:00AM.

We apologize for the inconvenience this may cause. Please understand that these works are essential for providing services to you and other residents in your neighbourhood. Due to traffic conditions, we are unable to conduct the work during daytime hours. We assure you that we will complete the work as quickly as possible while minimizing noise. We will implement noise mitigation measures, including the use of a low-noise generator enclosed in an acoustical enclosure.
