Relocation of Diamond Hill Fresh Water and Salt Water Service Reservoirs to Caverns



Please be advised that tunnel construction works, including arch rib installation and shotcreting, will be carried out at the construction site beneath Lion Rock Park starting from 2 May 2025, between 7:00 PM and 7:00 AM.

We apologize for any inconvenience caused. These essential works will provide critical infrastructure for the community. During construction, we will implement strict noise control measures, including the use of low-noise generators equipped with acoustic enclosures to minimize disturbance to residents.
