CHUN WO-SINHYDRO JV is the main contractor for the Water Supplier Department's contract 21/WSD/21. This Project is to relocate the existing Diamond Hill Fresh Water and Salt Water Service Reservoirs and associated facilities to caverns so as to release the existing site for housing and other uses beneficial to the people's livelihood while continuing to ensure an reliable, adequate and quality supply of water.

We wish to inform you that lifting operation will be conducted near the construction site on Chuk Yuen Road near Chuk Yuen Bus Terminus, from 20th June to 21st June 2025, between 24:00 and 05:00. Also, lifting operation will be conducted near the construction site on Chuk Yuen Road near Pang Ching Court, from 21st June to 22nd June 2025, between 24:00 and 05:00.

We apologize for the inconvenience this may cause. Please understand that these works are essential for providing services to you and other residents in your neighborhood. Due to minimize the effects of water suspensions to public, we are unable to conduct the work during daytime hours. We assure you that we will complete the work as quickly as possible while minimizing noise. We will implement noise mitigation measures, including the use of a low-noise generator enclosed in an acoustical enclosure.
